Welcome to the February edition of my e-Focus in which I update local residents on news items, council meetings and planning applications in the Alamein ward.

A draft budget for the new parish council for Andover has been set and will be included in the council tax proposals at this month's Test Valley Borough Council meeting (see over).

There is still no news on the future of the Guildhall. I have discussed the matter with council leader Ian Carr and we are awaiting a decision from Prezzo. If they pull out a panel of Andover councillors will look again at ALL alternative uses.

Changes in local bus services have been referred to the council's scrutiny committee for detailed investigation. I am currently discussing details of this with the chairman of the committee. Bus services were on the agenda of last week's Andover Forum where public opinion was very much against the new timetables. I hope to see the scrutiny committee deal with all the issues raised.

At the next council meeting I will be supporting Romsey councillor Mark Cooper's proposals for Test Valley to sign up to the 1010 campaign. See www.1010uk.org for more details of this campaign.


The plans for the redevelopment of Enham are now being considered by TVBC's planning department. If you have any queries or concerns please raise them with the planning department, or your local parish, or borough, councillors.

Objections to the re-routing of Smannell Road through the East Anton development will be considered by a public enquiry in April or early May. Contact me or Smannell parish council for more details. Also in Smannell I have raised the appalling condition of the road between Smannell and Little London with Highways officers and I expect a reply and action early in February.

I have also contacted Highways about the continual flooding of the footpath from Roman Way to the new pedestrian crossing outside Tesco on Smannell Road.
