Welcome to the September edition of my e-Focus in which I update local residents on news items, council meetings and planning applications in the Alamein ward. Following on from last month, the deadline for comments on the transfer of responsibility for concessionary fares to the county council is now passed. The matter will be discussed at today's (Sep 1st) Test Valley cabinet meeting and I have also tabled a motion to full council calling on the county council to continue to provide the same level of service as currently provided by Test Valley. We are still waiting a decision on the re-routing of Smannell Road. Since the public enquiry I have been contacted by many more local residents opposed to the plan. I hope to see that the inspector has listened to local views and keeps the existing road open.

I am pleased to report some action from Hampshire Highways in resurfacing the entrance to Galahad Close, dealing with overgrown trees on King Arthur's Way and a number of temporary repairs in other places. They have also responded to calls from town councillors Barbara Carpenter and Kevin Hughes to clear drains and repair street lights. If there are any other issues needing attention please let me know.

I can also report some action on under age drinking and the resultant littering of Smannell Road open space. Following two test purchasing operations where alcohol was sold to underage customers the police served a closure notice on Tesco Cricketers Way prohibiting the sale of alcohol over the bank holiday weekend. I fully support this move and hope the police continue to enforce the law in this area.

And finally another blight on the area is being addressed. Test Valley are looking at taking on additional powers to deal with abandoned shopping trolleys and would like your comments on their plans Follow this link for more details - <u>http://www.testvalley.gov.uk/Default.aspx?page=9843</u>
